2. FY2024 Annual Service and Budget Plan overview: Karen Dowell gave an overview of the total revenue and expenditures in the FY2024 budget.
3. Legislative updates: Dowell gave an update on legislation pertinent to MHDS and where it was currently sitting in the legislature.
4. Individualized Placements and Supports: Steve Tisue, Goodwill Industries of NE Iowa, explained what this service is and Goodwill's plan to move forward with the development.
5. Intensive Residential Support Homes (IRSH) updates: Bob Lincoln, Elevate, gave an update on the IRSH service they are developing and the remodeling of the home. Timeline still remains hopeful for 7/1/23 opening. Laura Peyton, Inspiring Lives, was invited to present on their IRSH home but was not in attendance.
6. Crisis Services monthly data collection presentation: Dowell presented preliminary charts being developed from the data crisis services providers are collecting and sending monthly to the regions.
7. Crisis Services updates: Bob Lincoln and Jenni Stevenson, Elevate shared updates on the crisis services Elevate provides and Brittany Davie, North Iowa Regional Services gave an update on the anticipated opening of the Brownstone Youth Crisis Stabilization Center, hopefully slated for May or June.
8. I-START Transition to Provider Prevention Support Services (PPSS): Tiffany Liska, Program Director, gave an overview of their program.
9. Recommendations to CSS Governing Board for consideration: There were no recommendations offered.
